



Relocation Checklist Before moving 1/2

Residence permit If you are staying for more than 3 months, you must have a valid work and/or residence permit. For citizens of EU-25*/EFTA states a simplified permit procedure applies. You can apply for your work and residence permit directly at the Migration Office of the Canton of Schaffhausen within 14 days after arrival and before commencing employment. Required documents include a valid identity card or passport as well as a written letter of confirmation from the employer (e.g. employment contract with stated duration of employment). For further information please visit www.sem.admin.ch. * For citizens of Bulgaria, Croatia and Romania, admission restrictions apply.
